Prime Value Cash Plus Fund Fund Update – May 2016



- Credit markets improved again helping the Fund deliver 0.67% in May
- The economies of Australia, China, Europe and the US are behaving quite differently, creating divergences in official monetary policy and local equity/ credit market conditions
- Given the divergences and global uncertainties, we continue to position the Fund conservatively to protect investor capital and pay a quarterly distribution above RBA Cash Rate

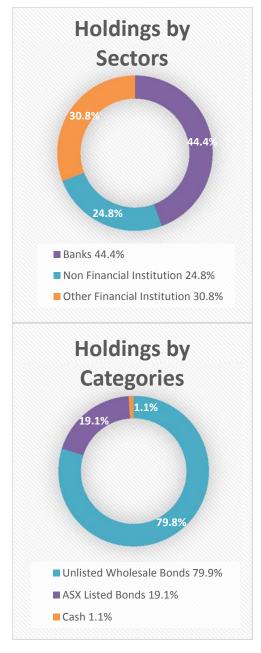

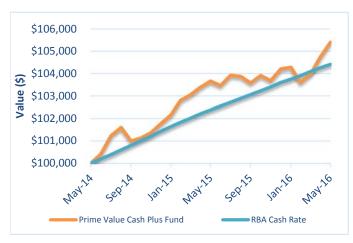


Fund review & strategy

The Fund return was 0.67% in May with global credit markets improving, and improved investment sentiment in the Australian stock market. This was partly bolstered by the RBA cut rate in May to 1.75% (an all-time low). The rally in bonds continued and the 3-year Australian Government bond yield reached an all-time low of 1.50%. Rate cuts in Australia with another expected stand at odds with the US where a further rate hike is widely expected at the June 14-15 Federal Reserve meeting. The dichotomy between the US and Australia caused the Australian dollar to fall (to around USD 0.7200) despite crude oil reaching US\$50 per barrel for the first time this year.

We continue to believe credit markets will show stability over the next 3-6 months with the only risk being a resumption of the volatility seen in equity markets earlier this year. Credit markets have comfortably absorbed the higher bond issuance seen in the last 6 weeks.

We remain vigilant to political developments in both Australia (Federal election July 2) and the US (party presidential nominations in June with the election November 8), economic data and official monetary policy actions in Australia, China, Europe and the United States. Whilst the "hunt for yield" has replaced the "flight to quality" theme of the first three months of this year, investor sentiment can change quickly and given the divergence in the performance of the major markets and economies around the world, we are committed to manage Fund investments conservatively to protect investor capital and continue to pay a quarterly distribution above RBA Cash Rate.

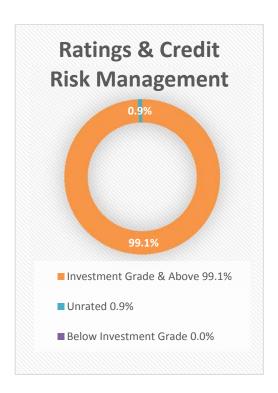

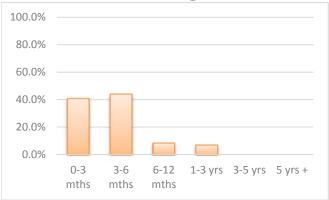
