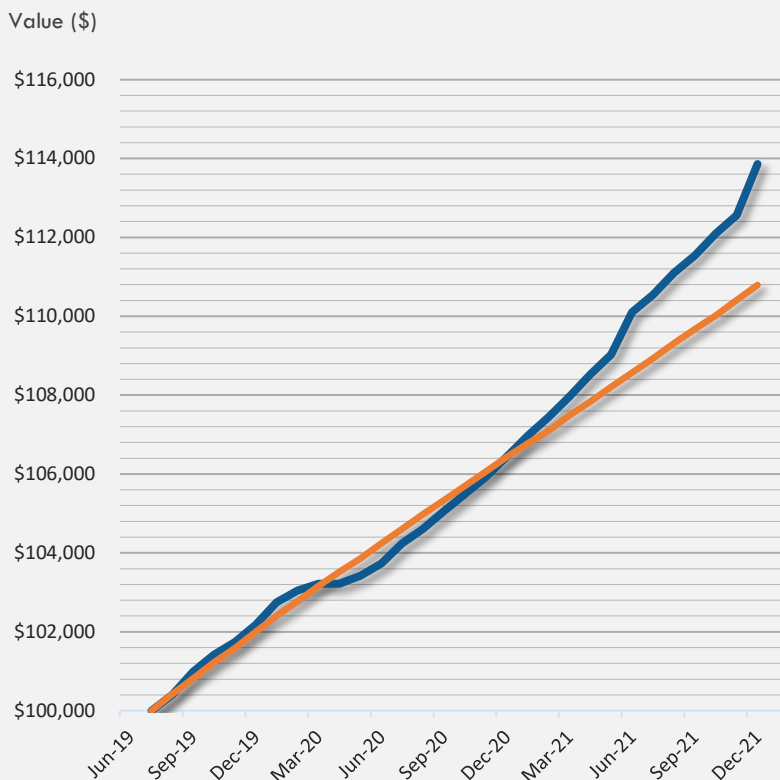


### One-Stop Shop

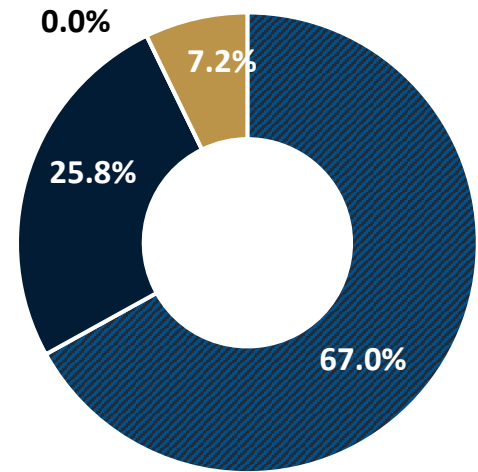


### Prime Value Diversified High Income Fund
