## Prime Value Opportunities Fund – Class B

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). It sets out the class of consumers for whom the Prime Value Opportunities Fund – Class B, including its key attributes, would likely be consistent with their likely objectives, financial situation and needs. Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

### **Description of Target Market**

#### Appropriateness

#### Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of *minor allocation* or *core component*). ### Target Market Summary

This Fund is intended for use as a *Minor* or *Satellite* allocation within a portfolio for a consumer who is seeking *Capital Growth* and has a *High* risk/return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a *3 year* minimum investment timeframe and who is likely to need access to capital within one week of request.

Distributor Reporting			
Significant dealings	Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning. The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its		
	distribution strategy, and to meet its own obligation to report significant dealings to ASIC.		
	Dealings outside this TMD may be significant because:		
	• they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or		
	• they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer).		
	In each case, the distributor should have regard to:		
	• the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes),		
	• the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and		
	• the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red or amber ratings attributed to the consumer).
